ONLINE STARDOM REGISTRATION GUIDE – IMPORTANT INFORMATION

Teachers or School representatives may submit entries on behalf of all of their students on a single Registration Form. If entering a school, select 'School Representative' as your user type.

GETTING STARTED

Go to the Lismore Eisteddfod webpage: <u>lismoreeisteddfod.com.au</u> and click on the "ONLINE ENTRY" link on your schedule page (Schedule under Eisteddfod 2024 tab)

- Signup for an account at the top right-hand of the homepage. Your secure login will now be available for current and future eisteddfods.
- Check and update your details for accuracy and administrative purposes.

HOW TO ENTER

- From the list of eisteddfods on the left side of the homepage, choose the Lismore Eisteddfod and click enter competition
- Select the Discipline/s and Section/s you wish to enter. Read the relevant rules and complete the entry process online.
- A STARDOM administrative fee of \$2 per Registration Form (regardless of number of competitors) is charged only once per Registration Submission, so always use the "Save and Exit" option if you need to leave STARDOM before completing your entries. You can return later without any loss of information.
- There is a \$5 Lismore Eisteddfod Fee **per competitor/troupe/school group** on the Registration form to cover such costs as copyright etc.
- Recheck all rules before completing payment
- Entries are only confirmed once payment has been received.

PAYMENT INFORMATION

- All Registration Payments must be in the Eisteddfod account by 5pm on the Closing Date
- Allow time for Electronic Funds Transfer to be cleared. (Some banks take several days)
- For Schools there is a print invoice option which allows you to bypass payment when you do registration of entries. Please follow through with your usual school payment procedures.

2024 RULES FOR GOVERNING THE SOCIETY'S SCHOOLS SECTIONS OF THE LISMORE EISTEDDFOD

Competitors are asked to study the following rules carefully as they will be strictly enforced. This applies particularly to the submission of entry forms which will be rejected if they do not comply.

ALL ENTRY FORMS WILL BE COMPLETED ON THE STARDOM PLATFORM VIA OUR WEBSITE: https://lismoreeisteddfod.com.au

- 1. In these rules and conditions the word "Committee" shall mean "The Management Committee of the Lismore Musical Festival". The decision of the Committee, in all questions arising, shall be final. All entries are deemed to be made subject to these conditions.
- 2. The Committee reserves the right to determine the Status of any competitor and the application and interpretation of these rules.
- 3. In the event of insufficient or large entries, the Committee reserves the right to combine **OR** divide sections accordingly. In any section where insufficient entries are received the Committee may exercise it's discretion with regard to the retention or the alteration of any section for that year.
- 4. The Committee reserves the right to amend the program at any time by varying the order of the competitors or sections at any session.
- 5. All competitions are intended for amateurs. Teachers may not compete.
- 6. All competitors perform entirely at their own risk.
- 7. The use of tape recorders, video cameras, or mobile phone cameras by members of the audience during the school performances is <u>strictly prohibited</u>. There are serious consequences for those breaching the Child Protection Act.

 Teachers will be allowed to take videos or still photographs of their own students during the school eisteddfod provided that:
 - a) Before the eisteddfod the teacher/school will let the parents know that they will be taking photos and videos.
 - b) Each teacher who wants to take videos/photos signs in at the Photography Register at the Music Desk.
 - c) **NO** flash photography during performances.
- 8 **AGE**: The age as at the **31st May 2024** shall be deemed to be the age of the competitor.
- 9. The Committee reserves the right in age competitions to call upon any competitor to produce, at his/her own expense, PROOF OF AGE, and to withhold any prize/money until such proof shall have been furnished.
- 10. The Committee reserves the right to refuse any entry.
- 11. Entries in all sections must be lodged on or before the date advertised for the closing of entries.
- 12. All entries should be made via Stardom on the society's website. Music files may be uploaded to Stardom.
- 13. Students must perform in OWN year sections, unless specifically indicated in the schedule as a combined section, open to all year groups.

- 14.It is not necessary to name OWN CHOICE items on the entry forms
- 15. In **OWN CHOICE** sections copies of sheet music for use of the Adjudicator must be handed to the Music Table Secretary immediately prior to the commencement of each SESSION (morning, afternoon or night) in which the item is to be heard.
- 16. In OWN SELECTION competitions, marks will be awarded for quality of choice. Very lengthy selections will not improve the competitor's chance of success and teachers are advised to take note of this.
- 17. **Time Limits**: Please read specific Schedules for time limits
- 18. The Adjudicator's decision shall be final and he/she has the power to withhold or divide prizes according to merit. He/she shall also be entitled to recommend the awarding of a second place if he/she thinks the rendition has not sufficient merit to carry a first prize, but the/she shall intimate his/her decision when making the adjudication.
- 19. In many cases only part of a song, recitation or instrumental item may be heard by the Adjudicator and the bell does not necessarily signify disapproval or rejection. The Adjudicator's objective will be to hear all items at the session in which they are set down.
- 20. If through unforeseen circumstance an Adjudicator is unable to perform his/her duty, the Committee reserves the right to appoint a substitute.
- 21. Competitors must assemble in the space provided by the committee and must be ready to render their items in the order in which their names appear in the program. Any delay on their part causing disruption of the business of the session will render them liable to disqualification.
- 22. No teacher will be allowed on stage with a competitor unless as an accompanist or conductor FOR THAT ITEM. Prompting from the audience or side of stage is strictly forbidden and is liable to result in disqualification of that competitor.
- 23. Any competitor requiring an accompanist please contact Lismore Musical Festival Secretary at least five weeks prior to the Eisteddfod.
- 24. The Vocal style of Belting is not acceptable.
- 25. A SOUND SYSTEM is provided by the Society and Competitors must use the standard equipment. A sound operator will be provided (No additional charge for this service). The Committee and/or Sound Operator will not be held responsible for CDs/USBs incorrectly marked.
- 26. CD and USB RULES:
 - a) Clearly label each CD or USB with Section Number, competitor number, start on or off stage.
 - b) Only one piece of music is to be recorded on each CD /USB.
 - c) If uploading music to Stardom prior to the competition, bring a backup on a USB
 - d) MP3 files can be played.
 - e) Under no circumstance is a sticker to be put on the actual CD. Leave CD in case.
 - f) Competitors must ensure that their backing can be played through an audio system.

- 27 CD and USB **Backing Tracks** may be used in all **vocal sections**. However, **No Vocals** are permitted on the backing track and accompaniment must be **ONLY** either piano or guitar. In Popular sections full band Karaoke tracks are acceptable. Please supply adjudicator with a copy of the sheet music All music files must be in **CDA FORMAT**.
- 28 Usage of venues or equipment PRIOR to the Eisteddfod is not the responsibility of the Lismore Musical Festival Society. All rehearsals should be privately arranged by, and paid for by the competitor with the appropriate authority.
- 29. No use of the stage for practice is permitted at any venue during the competitions.
- 30. During the actual competitions all enquiries of, or representations to the Adjudicator must be made in writing either through the Secretary or a Committee member. UNAUTHORISED communication with the Adjudicator during the competition is STRICTLY FORBIDDEN. Failure to comply will mean immediate disqualification.
- 31. **PROTESTS**: If any, shall be lodged with the Secretary in writing, within one hour after completion of section in respect of which the protest is entered and must be accompanied by \$50.00 which shall be forfeited if the protest is deemed to be frivolous or unfounded.
- 32. Competitors must change in dressing rooms. Public areas are not to be used as change areas.
- 33. The use of glitter spray and hair spray may be a health hazard for some competitors. These must be used with great care in a well-ventilated area, preferably in the open air.
- 34. No offensive or obscene language or swear words are to be used in performances. The Adjudicator has the authority of the Committee to terminate/disqualify a performance if it is considered offensive in any way.
- 35. Competitors will be regarded as being CONVERSANT WITH THE RULES of the competitions of the Society affecting their positions as competitors. The PLEA OF LACK OF KNOWLEDGE WILL NOT BE ACCEPTED AS A BONA FIDE REASON FOR THE INFRINGEMENT OF THE RULE. In the event of a protest being lodged the competitors so infringing shall be liable to disqualification or may otherwise be dealt with by the Committee.

• \$100 Encouragement Prize

will be awarded to a secondary school at the adjudicator's discretion.

\$150 Resonator Music Voucher

for an outstanding performance by a secondary school will be awarded at the adjudicator's discretion.

COPYRIGHT REQUIREMENTS

Responsibility for compliance and knowledge of Copyright Laws rests with the competitor and not with the society.

Every competitor needs to provide a printed copy of the APRA/AMCOS form to the Eisteddfod committee on the day of their first performance.

All of the pieces to be performed by a competitor throughout the Eisteddfod can be written on this one form.

MUSIC

1.ADJUDICATOR'S COPY

The competitor may supply the adjudicator with a photocopy provided that:-

- (i) the original is used by the competitor for performance
- (ii) the Eisteddfod Committee destroy the photocopies

2.COMPETITOR'S COPY

- (i) If the competitor is not performing from memory, original Or licensed photocopy must be used in the performance.
- (ii) The original can be a borrowed original, ie borrowed from a library, a friend, another competitor etc

3. UPLOADING MUSIC to STARDOM

- Music may be uploaded to Stardom.
- Advisable to bring a backup music file on USB.

HSC PERFORMANCES

This section is for those students who are presenting for the 2024 Higher School Certificate in Music.

- (a) Students will perform two pieces from their HSC performance repertoire.
- (b) Maximum performance time 10 minutes.
- (c) Maximum set up time 3 minutes
 - (i) If a student needs a longer set up, they will need to be at the venue half an hour prior to the session starting to set up their drum kit, or special amps etc, and have these ready to go at the back of the stage.

PHOTOGRAPHING and RECORDING PERFORMANCES TEACHERS ONLY

- Will be allowed to take videos or still photographs of their own students during the school performances and must sign in at the Photography Register at the Music Desk.
- See Rule 7, page 5 for full details of procedures to follow.

Time limit - maximum tent (10) minutes in total.

Two contrasting items.

Any age secondary school students

ALL ABILITIES VOCAL, INSTRUMENTAL AND DANCE

These sections are intended to celebrate all abilities and diversity in our community through vocal, instrumental and dance performance.

Prizes: First: Trophy Second: Medal Third: Medal Highly Commended: Certificate

Performers may receive any assistance they need on the stage.

This section is open to:

- Performers who are visually impaired.
- Performers who are hearing impaired.
- Performers who have a communication challenges.
- Performers with a learning or cognitive disability.
- Performers with a mental health or emotional challenge.
- Performers with limited mobility.

VOCAL ENSEMBLE

Time limit - maximum ten (10) minutes in total Two contrasting items within this time.

There may be vocals on backing track accompaniment.

Minimum of three vocalists.

Section 1140 - All Abilities Secondary School Aged Vocal Ensemble

INSTRUMENTAL GROUP

Time limit - maximum ten (10) minutes in total

Any variety or combination of instruments (including voice).

Two contrasting items within this time.

Minimum of 3 players.

Section 1141 - All Abilities Secondary School Aged Instrumental Group

DANCE

Time Limit - **5 minutes.**Group size - Minimum of 3 dancers
Any style of dance

Section 1142 - All abilities Secondary School Aged Dance Group
